



# SCCJA Verification & Certification of the Firearm Qualification

- (A) Candidate was given basic weapon safety, for both on duty and off duty carry

- (C) Candidate fired the qualification course required by the SC Criminal Justice Academy described below:

Basic Course of Fire Qualification:

**Stage 1** - From Holster-Shooters Choice from the Holster ---3 Yards/6 Rounds/Timed

2 rounds- 2 Seconds

2 rounds- 2 Seconds

**Stage 2** - From Holster-Natural Point-one hand shooting only---7 Yards/8 Rounds/Timed

2 rounds Strong hand 2 rounds Weak hand -10 seconds

2 round Strong hand 2 rounds weak hand – 10 seconds

**Stage 3** – From the Holster ---12 Yards/6 Rounds/Timed

4 rounds (Combat Load) 2 rounds-12 seconds

**Stage 4** – From the Weaver or Bladed Ready ---12 Yards/12 Rounds/Timed

2 rounds-3 seconds

2 rounds-3 seconds

2 rounds-reload-fires 2 more rounds-12 seconds

2 rounds-3 seconds

2 rounds-3 seconds

**Stage 5** – From Holster-Unsupported Barricade ---15 Yards/12 Rounds/Timed

3 rounds strong side standing and 3 rounds weak side standing (10 seconds)

3 rounds speed kneeling strong side and 3 rounds speed kneeling weak side kneeling

(12 seconds)

**Stage 6** - From Holster – From behind Barricade ---25 Yard/6 Rounds/30 Seconds

2 rounds rollover prone

2 rounds strong side kneeling supported

2 rounds strong side standing supported
